#### **NOMINATION CRITERIA:**

- Full-time or part-time budgeted employment in the VMTH
- Recipient must exhibit exceptional skills in many or all of the following areas
  - o Clinical Service by supporting clinical faculty in outstanding patient care.
  - o Patient Service through dedicated effort to prevent and cure disease in animal patients.
  - Client Service focusing on the needs of the animal owners, veterinarians and VMBS constituents to ensure an exceptional client experience.
  - Service to the Profession through the education of tomorrow's veterinarians.
- Individuals are eligible to receive the W. Terry Stiles Service Award if she/he has not received the award in the last five years.

#### **RECOGNITION/AWARDS:**

Recognition will include an award for \$500.00 to be included in the recipient's next paycheck (this award is taxable; therefore, taxes will be deducted from the recipient's check).
